Subjects for inclusion in the study of Church and Authority

Start from:

Two Churches with "two moral traditions, two concepts of authority, two life-styles" (Dunstan). Much in common but much divergence (Purdy). Development in divided Churches (Knapp-Fisher).

Authority in the world today (Chadwick). The breakdown of authority and the need to rehabilitate the whole concept of authority (Knapp-Fisher).

Return to: 'Our authorities'

God's will and purpose for the church and the world,

revealed in Christ - Our Lord - the nature of His Authority -

revealed by the Holy Spirit in the Church.

Sources of revelation and their interpretation and application:

Scripture, tradition, reason; church, councils, episcopate, faithful.

Normative principles; criteria.

On this basis:

Ecclesiology - the Mystery of the Church -

Koinonia in New Testament and early Church - a church structured for mission.

Typoi, "local Church", inter-relation of churches, and their structure, levels of authority, diversity in unity, comprehensiveness, primacy and primacies.

Schism and reconciliation,

The historical development in East and West of authority in doctrine and teaching, discipline and morals, jurisdiction, appeals and appointments.

Doctrine and teaching - hierarchy of truths - comprehensiveness - the limits of diversity - respect for Spirit-given diversity - dogmatic definitions and freedom of restatement - sensus fidelium - teaching office of bishops - Councils - bishop of Rome - guidance, indefectibility, infallibility, Papal and mariological definitions -

<u>Discipline and morals</u> - canon law - pastoral instruction - "the making, commending and enforcement of moral judgments within the Church" -

Jurisdiction - Papal, Patriarchal, Anglican and Episcopal - appeals and appointments - style of exercising authority.

Conclusion: The shape of authority in a united church.
