## 1. Reactions to the Canterbury Statement

Mgr. Purdy is preparing a paper on these which, supplemented by a similar paper from the Revd. Colin Davey, could form the basis for a general discussion of reactions to the Canterbury Statement at some point in the meeting at Grottaferrata. This would include the question of the publication of commentaries by members and the timing of their appearance.

(It was felt that after the completion of a Report on Church and Authority the Commission would need to write a Final Report, perhaps including a revision of its earlier work, and ending with conclusions or recommendations on steps to be taken on the basis of the agreement achieved. Cardinal Willebrands' suggestion was noted, that one or two new people might be brought in at that stage, to assist the assessment of the work done from an informed outsider's viewpoint.)

# 3. The shape of the Discussion of Church and Authority

(1) It was felt that our discussion should begin from, and never lose sight of, the question, "What prospects are there for a restatement of religious authority in the modern western world?" (Dr. Chadwick ARCIC 5: Some observations on Authority, its nature, exercise and implications p.8) as well as bearing in mind his exercise and implications p.8) as well as bearing in mind his other question (ibid) "What today are the fundamental differences other question (ibid) "What today are the fundamental differences on authority which Roman Catholics and Anglicans have inherited from past history, and which still have influence over the conversation between them?"

- (2) However, as with our earlier work on Eucharist and on Ministry, we should begin by re-examining what the New Testament has to say about Church and Authority, and precede this with a discussion of the authority of the New Testament itself.
  - To what extent is the New Testament an authority in Itself? In the light of current New Testament criticism and the tendency for example to separate the Gospels into three strata, the words of Jesus, the traditions and teachings of the primitive Church, and the redaction of the evangelists and their sources, what is the authority given by us today to each of these strata of tradition within Scripture, and what bearing has this on our discussion of the authority of Scripture and of Tradition?

- The Commission might move on from this point to a discussion of ecclesiology and koinonia.
  - Q. What kind of community does it appear that the first Christians thought Christ intended them to be? From the answer to this question, what first notions do we have of authority in the Church? What obligations did the first Christians feel they had to accept in the areas of both belief and conduct? What was the relative weight of conscience, of the individual and of the community, and how was this embodied in the ordained ministry? How did the Holy Spirit operate and authority function in situations of dispute and division?

- (4) A further discussion might concentrate more specifically on primacy.
