 - mixed marriages
 - moral questions
- 2. National ARC Bishops' meetings
 - meet once a year
 - fraternal contact
 - subjects: recognition of baptism
 - : mixed marriages
 - : ecclesiological questions
 - : pastoral issues
 - : Final Report
- 3. Regional ARC Bishops' meetings, e.g. Quebec
- 4. Regional ecumenical leaders conferences (Alberta, Ontario, Saskatchewan)

III. ARC/UNITED STATES

- 1. Anglican-Roman Catholic Consultation U.S.A.
 - initiated 1965
 - 27 sessions to date, meetings every 8 9 months
 - significant statements:
 - a. Statement of Goals (12/69) "restoration of full communion and organic unity"
 - b. Methodological principles (1/72)
 - c. Agreed Statement on the Purpose of the Church (10/75)
 - d. Twelve-Year Report (8/77)
 - e. Reflections on Christian Anthropology (2/83): providing a context for the discussion of such difficult questions as the role of Mary, the ordination of women, sexual imagery

- r. comments on ARCIC statements/elucidations Special Consultation on Ordination of Women (6/75)
- 2. Meetings of Anglican and Roman Catholic Bishops (1979-80): shared reflections on life and ministry of a bishop
- 3. Leaders Conference (6/81): bringing together of national lay and ordained leaders; several resolutions proposing further collaboration; especially at national level
- 4. Task Force on Spirituality (6/82)
