ANCLICAN/ROMAN CATHOLIC JOINT PREPARATORY COMMISSION THIRD MEETING

The Commission came into being in fulfilment of the Common Declaration of Pope Paul VI and the Archbishop of Canterbury in March 1966. In a new spirit of penance and hopefulness it called for serious dialogue founded on the Gospels and the ancient traditions (which) may lead to the unity for which Christ prayed."

The task at Gazzada was to survey the field and identify the themes on which dialogue might best centre. As a result, at Huntercombe we concentrated our attention on the theme of revelation and its embodiment in the life of the Church. Concurrently at both meetings a sense of the pressure of the time forced us to attend to practical matters and make certain recommendation:

It was exciting to find at the end of this that we felt the need and saw the possibility of plotting some course towards unity. The scheme adopted for our third meeting was an attempt to respond to this vision. Bishops McAdoo and Butler were asked to furnish papers with such a course in mind, and their common summary was made the basis of our discussion and recommendations.

These are set out in a report to be submitted immediately to

Pope Paul VI and the Archbishop of Canterbury. Obviously before they have seen

it we cannot give details of it, but we believe that in the perspective of

post-Reformation history this report stands out, as containing the first formal

joint statement ever made of the faith we rejoice to share. A just estimate of



the value and extent of this gives us confidence in moving forward on to more difficult ground, that of confronting seriously the differences that keep us apart.


We have made recommendations in this regard both for dialogue and for practical measures for growing together, but we feel that this moving forward by tackling difficulties will not prosper unless we widely share our experience and learn from each other at every level of life in our Communions.

We make these recommendations, aimed at deepening and enriching our common life in Christ, because we know that only the shared experience of renewal can show what further steps we must take. But it is clear now that, whatever these further steps may turn out to be, scholars on both sides should already be engaged in serious joint study of such difficulties as those arising out of the constitution and teaching office of the Church, the place of Mary in the faith and devotion of the Church, and ministry.

To meet in the island of Malta, overlooking on one side the traditional place of St. Paul's shipwreck and on the other the beautiful walled town of Mdina, was a memorable experience. It was heightened by the warm welcome of the Maltese people in general, and especially of His Grace, the Archbishop, Sir Michael Gonzi, the other bishops and clergy and the Jesuits at the retreat house of Mount St. Joseph.

We were greatly moved to know that on New Year's Eve the community of St. Paul's Collegiate Church, Rabat, undertook an all-night vigil of prayer and penance offered on behalf of our work, and most of our members joined in for a part of it.

As the preparatory task assigned to us is completed, we thank God for having guided and strengthened our efforts and blessed us with many personal insights, the fruit of much warm, human sympathy and friendship. In three meetings we have had only a single absentee, and that unavoidable. Nothing could have



been stronger than our own experience in the discussions to convince us of the value of utalogue and or prowing regether and of the vital need to extend these to every place where our Communions are in contact.
